Any equipment not returned or renewed by March 31st will result in the loss of the deposit. Requests to return equipment on dates and times other than listed must be requested in writing by March 1st 2020. A \$20 per week late fee will apply for each set of equipment not returned or renewed by March 31, 2020. Your signature below indicates your understanding of this policy and authorizes the loss of deposit and/or late charges including charges to your credit card if equipment is not returned by March 31, 2020.
